PARTICIPATION AGREEMENT/INJURY WAIVER

I, _____, as a parent/guardian of above mentioned minor do hereby release, acquit, hold harmless, and forever discharge Council Road Baptist Church (CRBC), its agents, agencies, servants, employees, and all persons, natural or corporate, in privities with them, from any and all claims or causes of action of any kind whatsoever, including, but not limited to actions, suits and/or claims, from any bodily injuries, death, or property damage which may be sustained by my minor child/ward, while participating in an event, camp or trip, using any and all facilities on CRBC property, participating in any activity on CRBC property, including travel to and from such activities, not resulting from the intentional act or acts by any agent, servant, or employee of CRBC.

It is acknowledged that my decision to allow my minor child/ward to engage in activities with CRBC is entered into freely, and that CRBC, its agents, agencies, servants, and employees have not influenced my decision to allow my child/ward to engage in such activities.

I acknowledge that CRBC is unwilling to permit my minor child/ward to participate in any event or use the facilities on CRBC property without a signed waiver by me.

Because CRBC has instituted an electronic check in system, I agree that by my minor child/ward signing in, this waiver will continue to be considered in full force and effect unless/until revoked in writing. Further, that each and every time my minor child/ward signs in to use CRBC facilities, that such "signing in" shall automatically be considered authorization by me unless and until I revoke this waiver as provided above. I hereby agree to indemnify and hold CRBC harmless from any type of injury or loss that my minor child/ward sustains or incurs, if ever. My agreement to indemnify and hold CRBC harmless is continuing in nature and shall not be considered ineffective unless and until waiver is revoked.

This waiver shall be continuing in nature and only needs to be signed by myself one time for my minor child/ward. Unless/until this waiver is revoked in writing by me as the parent/guardian with the revocation delivered to the appropriate party at CRBC, this waiver is binding and shall be in full force and effect every time my minor child/ward uses any CRBC facilities. If revoked, such revocation does not revoke prior use or any injuries already incurred/sustained.
